**RESOLUTION AUTHORIZING QUANTUM MERUIT PAYMENT TO WAKE  
FOREST UNIVERSITY BAPTIST MEDICAL CENTER FOR MAMMOGRAPHY AND  
CHEST X-RAY SERVICES**

**WHEREAS**, Wake Forest University Baptist Medical Center, has provided mammography, diagnostic services, and chest x-rays for patients referred by Public Health for the benefit of Forsyth County; and

**WHEREAS**, the County had a contract with Wake Forest University Baptist Medical Center at a not-to-exceed amount of \$45,500 for Fiscal Year 2018; and

**WHEREAS**, the County amended this contract by \$40,000 to increase the not-to-exceed amount for Fiscal Year 2018 to \$85,500; and

**WHEREAS**, the County has received an invoice for these services which is more than the not-to-exceed amount by \$5,313.08 for which Wake Forest University Baptist Medical Center has not been compensated by Forsyth County;

**NOW, THEREFORE, BE IT RESOLVED** that the Forsyth County Board of Commissioners hereby acknowledges that the mammography, diagnostic services, and chest x-rays have been provided by Wake Forest University Baptist Medical Center, during the 2017-2018 fiscal year at a cost exceeding the contract amount by \$5,313.08 for which the Wake Forest University Baptist Medical Center has not been compensated by Forsyth County.

**BE IT FURTHER RESOLVED** that the Forsyth County Board of Commissioners hereby authorizes payment by Forsyth County in the amount of \$5,313.08 to Wake Forest University Baptist Medical Center, for mammography, diagnostic services, and chest x-rays during the fiscal year 2017-2018 on the basis of quantum meruit for the reasonable and just value of services rendered and acknowledged as a benefit to Forsyth County and for which the County received the benefits with the expectation of payment being made for services.

**BE IT FURTHER RESOLVED** that the County Chief Financial Officer is hereby authorized and directed to make payment as provided herein to Wake Forest University Baptist Medical Center, based upon acceptable written documentation submitted by the said provider.
