**SUMMARY OF INFORMATION:**

Attached is a list of various pieces of equipment, furniture, janitorial supplies, and miscellaneous items that have been replaced by County departments and are surplus to the needs of Forsyth County.

N.C.G.S. 160A-270 authorizes the sale of surplus personal property by public electronic auction. On August 10, 2009, the Forsyth County Board of Commissioners adopted a Resolution authorizing the County Manager to execute an agreement with GovDeals, Inc. to conduct public auctions of personal property electronically and authorized the sale of designated surplus personal property by resolutions adopted on August 9, 2009, March 29, 2010, July 11, 2011, and February 27, 2012 utilizing the electronic website, which sales were very successful.

The charge for this electronic auction service is a basic fee of 7.5% of the winning bid, but not less than \$5.00 for each auction item which yields \$100,000 or less. The basic fee is less if an item sells for greater than \$100,000.

Staff recommends that the Forsyth County Board of Commissioners declare the items on the attached list surplus to the needs of Forsyth County and authorize their sale by public electronic auction utilizing GovDeals, Inc.
