Meeting Minutes

April 23, 2024 – 5:00 p.m.

Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the 2nd Floor Board Room on Tuesday, April 23, 2024, at **5:00** p.m., Chairperson Robert Durrah, Jr. presiding.

Pledge of Allegiance

Chairperson Robert L. Durrah, Jr. led the Pledge of Allegiance.

Moment of Silence

Chairperson Robert L. Durrah, Jr. led a moment of silence.

Public Comments

Chairperson Robert L. Durrah, Jr. called for public comments, providing two minutes per speaker:

Approval of Meeting Minutes

Secretary Doomy presented the meeting minutes for April 9, 2024, meeting. Member Draper moved to approve the minutes as presented; Vice Chair Jourdan seconded. **Motion carried unanimously.**

Approval of Absentee Ballots

Deputy Director Michelle Bobadilla presented to the Board a total of 76 absentee ballots for approval, of which 75 are civilian ballots and one is military; and a total of 3 absentee ballots for disapproval. Member Draper moved to approve 76 absentee ballots with 1 being a military ballot and to disapprove 3 absentee ballots; Member Harvey seconded. **Motion carried unanimously.**

Board Members signed Zero Reports for the DS850 high-speed scanner.

Board Members signed absentee voter reports for the approved and disapproved ballots.

Discussion of One-Stop Early Voting Plan for November 2024 Election

Mrs. Bobadilla presented to the Board a draft of the Early Voting plan as discussed in the previous meeting on April 9, 2024, with some updates of potential early sites. The Kernersville Fire Station #42 is an option for an additional site in Kernersville, and the United Metropolitan Missionary Baptist Church is an in-lieu of site for the Forsyth County Government location. Additional locations for Clemmons have been looked at, however, nothing at this time is available. Chairperson Durrah called for a motion to table the vote for the Early Voting plan. Secretary Doomy moved to table the decision on the early voting plan until a future meeting; Member Harvey seconded. **Motion carried unanimously.**
